## Leadership Overview

Since my initiation into Alpha Phi Alpha Fraternity, Inc. in the spring of 2006, I have worked with fidelity to promote the fraternity's national programs, initiatives, and objectives on local, district, regional, and national fronts. As a College Brother, I served the Eta Delta Chapter in the offices of Associate Editor of the Sphinx, Recording and Corresponding Secretaries, and Second Vice President. In addition, I served as Chairman of the Miss Black and Gold Scholarship Pageant, Scholars Bowl, MLK High School Oratorical Contest, March of Dimes, and Relay for Life Committees. Upon graduation, I joined the Iota Pi Lambda Chapter and used my collegiate experiences to improve my graduate chapter's local activities. As an Alumni Brother, I have had the opportunity to serve the Iota Pi Lambda Chapter as its Associate Editor of the Sphinx, Recording Secretary, College Chapter Advisor, Vice President, and now Chapter President. While as a committee chairman, I revamped Iota Pi Lambda's Brother's Keeper, March of Dimes, Relay for Life, fundraising, and community service programs. **Through my vision of creating a network of community partners – concerned citizens, businesses, fraternal groups, and nonprofits – the Iota Pi Lambda Chapter has been able to exponentially increase its impact and influence on the communities of southern Miami-Dade County.**

**As I have navigated the ranks of the Fraternity, it has been my personal mission to mentor and empower all Brothers desiring to advance the vision of our Seven Jewels.** As a Chapter President and College Chapter Advisor, I had the duty of leading, motivating, and inspiring Brothers in different seasons of their fraternity membership. I am vigilant in my effort to overcome the challenges posed in uniting people together and working strategically to maximize our collective output. I enthusiastically support the Eta Delta Chapter in its efforts to stimulate growth and cultivate the professional development of its members. I am inspired by the energy our College Brothers continuously inject into our Fraternity and am humbled to serve as a guide on their journey through College Life. On both fronts, I am encouraged by the confidence the Iota Pi Lambda and Eta Delta Chapters have entrusted in me and the opportunities these positions offer to propel the mission of our great fraternity forward.

Concurrently, I also serve on the Iota Pi Lambda Education Foundation Board. The Foundation serves as the service and philanthropic arm of my chapter. In this capacity, I served as the Foundation's Scholarship Committee Chairman, Secretary, Vice President, and am its immediate Past President. While a member of the foundation's executive leadership team, I worked for five years to restructure the organization from the ground level – instituting an annual minority youth scholarship program, implementing its' adopt-a-classroom project, creating several comprehensive community outreach programs, establishing a youth mentoring program, and coordinated its involvement with domestic and international relief campaigns.



Extending beyond my local activities, I have assisted in the coordination and implementation of numerous Florida District programs, Southern Region initiatives, and national political and social action projects. Most notably, I have served as the FFAC Belford V. Lawson Oratorical Contest Committee Chairman, Editor to the Florida District's Torch Newsletter, Co-Chairman to the South Florida Area Founders' Day Celebration Weekend of Activities, FFAC Miss Black and Gold Scholarship Pageant Committee, 2020 Protect the Vote National Committee, South Florida Area Director, and Southern Region Director of Community Engagement and Strategic Partnerships . Currently, I serve as the Florida District's Chief Impact & Engagement Officer, Interim FFAC Executive Director, and Member-at-Large on the Project Alpha, Strategic Partnerships, and Big Brothers Big Sisters National Committees. Periodically, I have also served as a presenter during Alpha University on the duties of Chapter Historian, Associate Editor of the Sphinx, Director of Educational Activities, and IMDP education sessions.

In addition to my service to Alpha, I am a proud member of Prince Hall Freemasonry and volunteer with several youth and community health organizations. Notably, I have been a member of the 5000 Role Models of Excellence Project since 1998, having been a former youth participant and now as a Mentor. As a recipient of the I Have a Dream Foundation Scholarship, I mentor K-12 and college students on the importance of a college education, offer admissions guidance, and career development counseling. For my expertise on college admissions, I have been asked to serve as a feature speaker to students at over a dozen high schools across Miami-Dade County and provide pro bono admissions services through my company, Sphinx Tutoring and Academic Services. Furthermore, I am active on local taskforces which support the research and advocacy work of our national partners the March of Dimes and American Cancer Society.



## Health Education & Promotion

As a clinical research assistant, I have had the opportunity to work on several research projects on issues that grossly affect African Americans. I have had the privilege to complete a clinical investigative research internship to develop a patented universal oral rinse test for early detection of oropharyngeal cancers. To advance the mission of our project, I volunteered to create and implement educational initiatives and analysis of experimental data collected from a head and neck cancer pilot study underway in the Liberty City, Florida community. For this initiative, I developed educational brochures and flyers on the study and cancer awareness for participants, facilitated workshops for community members on the project, and fostered relationships between my research lab and several pharmaceutical companies to acquire resources to support the study. Additionally, I have worked to recruit research participants to determine HIV prevalence in various zip codes across Miami-Dade and Broward counties. For this project, I worked to educate community members and study participants on the importance of HIV/AIDS testing, infection prevention, and available treatment.

**Coupling my field and advocacy experiences, I am leading the Iota Pi Lambda and Eta Delta Chapters in their joint effort to conduct a robust Project Alpha Virtual Series for youth and young adults through the fraternity's AIDS Healthcare Foundation Pilot Program.**

As a member of the Ancient Egyptian Arabic Order Noble of the Mystic Shrine, I maintain several positions within Kazah Temple #149. As Chief Rabban I have worked to incorporate modern day technology and business practices into our daily operations. In doing so, I have streamlined Kazah's digital communication, reporting measures, and financial accounting practices - from its antiquated model - to meet conventional standards. Besides being a member of the Divan, I also serve on several of the Temple's community outreach committees. As chairman of the Temple's Community Health Initiative Committee, I have led the Temple to raise over \$5,000 for the South Florida Chapter of the American Diabetes Association within the past three years. In conjunction with our philanthropic efforts, I secured a

MOU with the Jessie Trice Community Health Center as part of a strategic health awareness campaign for the residents of the City of Opa-Locka and Miami Gardens. Our health awareness partnership includes designing educational literature on health conditions disproportionately affecting people of color and distributing this information via social media and print publication streams. Additionally, we provide periodic on-site health screening and education forums in several community and residential facilities within the City of Opa-Locka, FL.

In 2021, I organized COVID-19 vaccination distribution sites in both the northern and southern ends of Miami-Dade County. This granted me the opportunity to form collaborative partnerships with the South Florida I DID It Campaign, Nomi Health, and the Office of Equity and Inclusion under the direction of the Miami-Dade County Mayor's Office in a concerted effort to educate and immunize citizens residing in covid infection hot zones across Dade County.

In 2022, I had the pleasure of fostering a partnership between the Southern Region of Alpha Phi Alpha Fraternity, Incorporated and the American Red Cross (ARC). To debut this partnership, we launched the Hearts of Gold Blood Drive during Alpha South's regional convention. During this inaugural activity, we collected 109 units of whole blood and set a historical record for the state of South Carolina for the largest number of whole blood units donated in a single day. In addition, Bro. Kues and the Eastern Carolina Chapter of the American Red Cross facilitated a CPR and AED certification training free of charge for Brothers. Presently, I serve as the liaison between the Southern Region and ARC to foster employment, professional development, humanitarian relief, and community outreach activities opportunities for brothers and local chapters operating throughout the states of Alabama, Mississippi, Florida, Georgia, Tennessee, and North & South Carolina. Since the inception of this partnership, my leadership has resulted in over 1,000 units of whole blood products collected in conjunction with the 1,006 blood donor campaign.





## Community Advocacy

I developed the Alpha Leads through Education, Advocacy, Development, and Service (L.E.A.D.S.) Project to address a need for southern Miami-Dade residents to be better informed and more engaged on matters pertaining to health, education, and public policy.

Our first program held was an expungement clinic. In conjunction with the Miami-Dade Public Defenders Office of Carlos J. Martinez and Florida House Representative Kionne McGhee, the Iota Pi Lambda Chapter hosted a restorative rights resource clinic in Homestead, FL. Legal experts, and representatives from local and state administrative offices, provided their services at no cost to attendees. Event attendees were treated to light refreshments and received counseling on a range of restorative rights resources; event facilitators helped to answer questions and determined what services patrons may best qualify for. Correspondingly, qualifying participants were guided by onsite staff who helped prepare their Florida Department of Law Enforcement (FDLE) Application for Certification of Eligibility and gather all necessary documents for the submission of the application. Collectively, we were able to serve nearly 50 Miami-Dade County residents, 24 of whom received restorative rights services. The event was the first restorative rights workshop hosted by the Miami-Dade Public Defender's Office.

**Due to the recent emergence of legal precedents that challenge American civil liberties, and/or hinder access to the democratic process, it has become essential to create opportunities that bring about restorative forms of justice geared towards those populations who are most in need of it.** It was my hope that by providing these services, participants regain equitable access to the workforce, education, and the ballot. With this objective in mind, our chapter decided to target the often marginalized (and neglected) South Miami-Dade municipalities to facilitate a seal, expungement, and restorative rights processes event. It was our hope that an event of this nature would bring solace to a multitude of families, and we also believed that a project of this scope may serve as an impetus to many others who wish to engage in future social service endeavors.

To galvanize local community groups, I worked to form the South Dade Divine 9 Pact to pool the resources of the Black Greek Letter Organizations serving the communities of South Dade. After leading the coordination and execution of a live streamed Mayoral Candidate Forum on July 30, 2020, the Pact unanimously elected me to serve as its leader and develop its strategic plan to encourage voter engagement in preparation for the November Presidential Election. Following the event, I have directed the strategic distribution of collateral material on voting registration, vote by mail, and census completion in low voter turnout precincts across southern Miami-Dade County. Over three months, I coordinated the activities for a dozen groups - over 100 volunteers per canvassing event - to distribute voter education materials.

As a result of the success of the Alpha LEADS project, the Iota Pi Lambda Chapter has received grant funding from Black Voters Matter and When We All Vote to continue its efforts to educate southern Miami-Dade County residents on public policies that affect their standard of living

and provide them the tools necessary to become catalysts of change. These programs include hosting community forums on relevant public works activities in the community, workshops on public advocacy, working with community partners and government officials to adopt policies that benefit residents who reside in urban, suburban, and rural areas, distribution of voter education materials, programs to educate youth and young voters on civic responsibility, political & social justice, environmental justice, home ownership, entrepreneurship, and wealth building. Our youth programs have been expanded at multiple high schools within our community with the support of our nonprofit partners serving the area. Thus far, I have secured partnerships from two state universities, organic gardening nonprofits, and the Miami-Dade Professional Chapter of the National Society of Black Engineers (NSBE) to help facilitate the academic portion of the environmental justice program during the 2021-2020 school year. Through my service with AmeriCorps, I can continue to work with several organizations dedicated to improving our community through civic engagement and advocacy.





## Philanthropy

As connoted by Alpha Phi Alpha's aims - Manly Deeds, Scholarship and Love for All Mankind - charity and philanthropy help to form the underpinnings of our great Fraternity. Since my admission into this Fraternity in 2006, I have worked diligently to support Alpha Phi Alpha's commitment to its various philanthropies and related charitable ventures within southern Miami-Dade County. My personal commitment to health promotion and education has inspired me to lead my chapter's fundraising efforts for the March of Dimes and Relay for Life.

Recognizing the need for creative fundraising models for my small chapter, in 2019 I instituted the Wings for Babies Competition as a March of Dimes Fundraiser which allowed us to triple our fundraising results. To do so, I worked with Bro. Ricky Stuart to foster a partnership between the Iota Pi Lambda, Eta Delta, and Zeta Alpha Lambda Chapters with Hurricane Grill & Wings to raise funds for the March of Dimes. Together, we raised over \$4,600 in support of the March for Babies South Florida Philanthropy Campaign. **Within a year, I led Iota Pi Lambda from raising several hundred dollars to ranking third place amongst Miami-Dade County March of Dimes Civic Organization Donors.** That same year, Alpha Phi Alpha Chapters within Miami-Dade and Broward Counties collectively raised nearly \$7,000 in support of March of Dimes.

Impart to the COVID-19 pandemic, we were unable to host the 2020 and 2021 Wings for Babies Competition. Despite this hardship, Iota Pi Lambda raised over \$6,000 for the Miami-Dade County

Chapter of the March of Dimes in the spirit of the Gwen Carmon Alpha/Zeta Challenge. **In the future, Bro. Stuart and I hope to expand the Fraternity's local partnership to its 700 chapters located throughout the country and the markets of the FAT Brands, Inc. family of restaurants.** FAT Brands is a leading global franchising company that strategically acquires, markets, and develops fast casual and casual dining restaurant concepts around the world. The company currently owns seven restaurant brands - Fatburger, Buffalo's Cafe, Buffalo's Express, Hurricane Grill & Wings, Yalla Mediterranean and Ponderosa and Bonanza Steakhouses - with over 300 locations open and more than 300 under development in 32 countries.

As co-chairman, I worked closely with my chapter's Relay for Life Committee to devise a plan to execute our philanthropic goals. As a result of the generosity and commitment of our Brothers, we were able to donate over \$12,000 to the American Cancer Society through our team and memorial fundraising efforts over the past three years. Additionally, I have extended my expertise in coordinating small group philanthropy fundraising to the local Prince Hall Shriners efforts for the South Florida American Diabetes Association. **As its team captain, the Miami Prince Hall Shriners have raised over \$5,000 in honor of their National Diabetes Initiative during 2020-2022. To date, this is the largest amount ever raised for the American Diabetes Association by a single PHA Shriener Temple in the country.**



## Youth & Mentoring

In support of the Southern Region's FOCUS HBCU Initiative, in 2019 I devised a plan to partner with the Pi Delta Omega Chapter of Alpha Kappa Alpha Sorority, Inc. to conduct a HBCU Fair at Homestead Senior High School. This event proved to be the first activity of its kind held at the school. As a result of our collaboration, we were able to assist over 60 high school seniors gain admission into at least one of our 40 HBCU Partner Schools.

Per the requests of the students, we returned to the school to host a HBCU admissions boot camp. For this session, I developed a guide sheet to assist students in determining which schools they would like to apply to and personally met with each student to help tailor their application list. **By the conclusion of our fair and admissions book camp workshop, we helped to facilitate over 100 HBCU acceptances and nearly 1.5 million dollars in merit scholarship dollars awarded to students at Homestead Senior High School.**

Impart to the global pandemic, in 2020, the South Dade Alpha and AKA Chapters ventured into a virtual series format open to students across Miami-Dade County. We launched our program at 14 partner high schools and pledged to directly assist their students on admissions to HBCUs and provide college assistance program support through Alpha Kappa Alpha Sorority's #CAP Program. As a result of our previous success, Miami-Dade County Public School District, United&Unlimited, the National Society of Black Engineers (NSBE) and City Year partnered with us to expand the reach of this program. Thanks to the support of NSBE, our program model has been able to highlight unique STEM education and scholarship opportunities available for students attending HBCUs across the country. Participants of the series included students and high school counselors throughout Florida, Georgia, North Carolina, South Carolina, Texas, and the Bahamas.

During the winter and spring terms, we held our hybrid HBCU Admission Bootcamps series to help students navigate the admissions process. In

conjunction with our sorority partner's HBCU 4 Life and #CAP Programs, we hosted virtual workshops on FAFSA, personal statement writing, resumes, and provided tips on how to create competitive scholarship applications. **By the completion of both target programs, we were able to facilitate the award of over 500 HBCU admission acceptance letters and over \$16 million in merit scholarships to 2021 FOCUS participants over four years. The success of the program during a pandemic helped to cement our partnership with Miami-Dade County Public Schools and 40+ HBCU Partners to recruit students from the area and offer them adequate support and financial resources to attend their respective universities.**

For the consistent outcomes I have achieved within my local chapter, I was asked to coordinate a FOCUS HBCU Fair during the Southern Region Convention. The region's FOCUS HBCU Fair was the opening activity of the convention, serving as one of several community initiatives held during our gathering. Approximately 800 South Carolina high school juniors and seniors (from Horry and its neighboring counties) convened at the Myrtle Beach Convention Center. The event featured over 30 HBCUs from across the country and a dozen educational partners to facilitate on-spot admission, preferred admission, and scholarship giveaways. During our event, our HBCU partners awarded over 350 college acceptance letters and \$5 million dollars in merit scholarship dollars. Additionally, the Southern Region and its educational partners awarded eight \$1,000 scholarships to high school and students during the program.



In response to the Fraternity's call to increase efforts in youth mentoring, I have worked conscientiously to develop the Iota Pi Lambda Chapter's Men of Tomorrow: Alpha Phi Alpha Leadership Academy. Our program recruits middle and high school age boys. MOT participants are paired with Chapter Brothers who volunteer to serve as their mentors based on their capability and mutual interests. Participants meet twice a month, alternating between our structured workshop programs and tutoring. As the MOT Community Resource Liaison, I am charged with the responsibility of securing African American male professionals to speak at our signature workshops. Our workshop topics include mental health, health and wellness, peer pressure, and goal setting. MOT members earn service hours by participating in our chapter community service projects. In addition, I personally work with our high school seniors to guide them through their college admissions and scholarship search process. **With my assistance, Paul Griffin - our graduating Class of 2020 member - received full ride scholarship offers to attend college at four of our partner HBCUs.**

**Inspired by the need for increase dialogue with our youth, I created a virtual series to encourage healthy conversation and dispersion of knowledge to young men within the community.** AMOS, the Alliance of Men Oriented in Service, Virtual Youth Dialogue Series serves to bridge the generational divide between working male professionals and local boys under a banner of respect, understanding, and tolerance. Given the significant number of boys growing up in single family households, AMOS provides an alternative means for youth to receive

sage wisdom often passed down from father to son. It is a ten-part dialogue series targeting school age Black and Latino boys across Miami-Dade County. Throughout the fall and spring seasons, attendees participate in thought provoking discussions featuring African American men who are experts in their field sharing their insight on a different topic of focus. This past year's discussion topics focused on making wise decisions, the history of Black Miami, youth wealth building opportunities, career options after college, community policing, and forgiveness. The host groups include the Iota Pi Lambda Chapter, Pi Nu Chapter of Omega Psi Phi Fraternity, Inc. Richmond Heights-Perrine Alumni Chapter of Kappa Alpha Psi Fraternity, Inc. Men Mold Men (Triple M) Youth Group, and Miami Prince Hall Shriners. Youth participants range from elementary school to college students with a simple focus of empowering the next generation of men to resist the temptation of crime and set their ambitions for success.

Committed to my own personal growth as a leader, I have participated in numerous Alpha University and other fraternity hosted leadership development opportunities over the years. Aptly, I have completed several community leadership development institutes facilitated by university, government, and nonprofit entities serving the residents of Miami-Dade County. My participation in these leadership education programs have allowed me to further cultivate my skills as a community organizer, grant writer, and public policy advocate while promoting the mission of our fraternity.



## Daily Inspiration: Meet Leslie Elus

December 2021

Hi Leslie, please kick things off for us with an introduction to yourself and your story.



Growing up in a close-knit Haitian family, I learned the importance of service and community from a very young age. For over a decade, I have worked with the Iota Pi Lambda Chapter of Alpha Phi Alpha Fraternity, Inc. (South Dade Alpha) to reignite the fraternity's engagement in southern Miami-Dade County. Some of the activities I have led include instituting an annual minority youth scholarship program, adopt-a-classroom project, revamping several community outreach programs, establishing a youth mentoring program, coordinating fundraising efforts for March of Dimes and American Cancer Society, and facilitating the South Dade Alpha's involvement with a number of domestic and international relief campaigns.

Alright, so let's dig a little deeper into the story - has it been an easy path overall and if not, what were the challenges you've had to overcome?

Access and limited resources pose the greatest challenges to community engagement and advocacy efforts at large. At times, it feels like the needs of the community eclipse my best efforts to combat inequalities in my areas of focus, notably in education, healthcare, and socioeconomic. With these challenges in mind, it is important to foster collaborative ventures with groups who share similar ideals. Equally, it is important to identify individuals with vested interests in the public trust and wellbeing of all to foster real change.

As the President of the Iota Pi Lambda Chapter of Alpha Phi Alpha Fraternity, Inc. I provide vision for my fraternity's local implementation of its activities. ## South Dade Alphas, County and State Agencies Collaborate to Restore Rights of Local Residents

The Iota Pi Lambda Chapter of Alpha Phi Alpha Fraternity, Inc. hosted a restorative rights resource clinic in conjunction with the Miami-Dade Public Defenders Office of Carlos J. Martinez and Florida House Representative Kionne McGhee in Homestead, Florida.

Due to the recent emergence of legal precedents that challenge American civil liberties, and/or hinder access to the democratic process, it has become essential to create opportunities that bring about restorative forms of justice geared towards those populations who are most in need of it. Legal experts, and representatives from local and state administrative offices, provided their services at no cost to attendees.

"We are here to help as many people as possible...if you have a past record that should not keep you from working..." says Carlos J. Martinez, the lead attorney in the Miami-Dade County Public Defenders' Office during his welcome address at the July 20th event. "We can check out a few things and try to help everyone...We have a lot of young people here and [local agencies] to make sure we do all we can to have your rights restored."

The event was the first restorative rights workshop hosted by the Miami-Dade Public Defender's Office.

Community partners for the expungement clinic included: the Miami-Dade State Attorney Office of Katherine Fernandez Rundle, Miami-Dade County Elections, Miami-Dade County Police Department, Florida Restorative Rights Coalition, Career Sources Florida, and Avant School of Excellence. Thanks to the Haitian Lawyers Association, Florida New Majority, and United & Unlimited, the clinic was able to provide several FDLE Application Fee Vouchers.

Event attendees were treated to light refreshments and received counseling on a range of restorative rights resources; event facilitators helped to answer questions and determined what services patrons may best qualify for.

Correspondingly, qualifying participants were guided by onsite staff who helped prepare their Florida Department of Law Enforcement (FDLE) Application for Certification of Eligibility and gather all necessary documents for the submission of the application.

"We are here because we are doing some great things in the South [Miami-Dade] people," says Florida House Representative Kionne McGhee during the event streamed on Facebook Live.

## KAPPA KAPPA University of Arkansas Fayetteville, Ark.

AFTER RECEIVING DEVASTATING news about Jamaya Johnson and her battle with cancer, Kappa Kappa Chapter brothers at the University of Arkansas in Fayetteville, Ark. sprung into action and created "A Desire for Jamaya" bone marrow donor registration drive. The event was held in late February on the university campus.

Johnson, 14, is an eighth-grade student from Louisiana who has battled blood cancer for two years. Doctors say her only hope to survive lies in getting a bone-marrow transplant; however, no members of her family are a suitable match.

**ETA DELTA CHAPTER University of Miami Shows Actions Speak Louder**

THE 2010-2011 ACADEMIC YEAR is proving to be a quite busy one for the brothers of Eta Delta Chapter at the University of Miami (UM) in Florida. Just before school started, members capped off a summer of service mentoring young people for the Kulula Project in Miami's Coconut Grove neighborhood.

The Kulula Project is a program of the UM School of Education, a year-long mentorship program which provides activities rooted in African culture and history. Topics discussed covered self-awareness, relationship-building, skill-development, leadership-training and community service. Brothers mentored a group of 30 children, ages five to 14, and also took the group on a museum field trip and held ongoing discussions about college education and careers.

At the beginning of the school year, in collaboration with the Iota Pi Lambda Alumni Chapter in the Richmond Heights neighborhood, brothers took part in a back-to-school supply drive for Caribbean Elementary School in South Miami-Dade County. The university's

William R. Butler Center for Volunteer Service and Leadership Development assisted the brothers. Through this joint effort several hundred dollars in much-needed school supplies were donated.

By October, brothers began putting their feet to work to help women and help find a cure for cancer. On Oct. 10, they participated in the 6th Annual Walk for Myeloma, hosted by Beta Sigma Chapter of Lambda Theta Alpha Latin Sorority. The chapter made a financial contribution, and brothers participated in the opening ceremonies and the walk around Lake Osceola on the UM campus.

Several days later, on Oct. 16, Eta Delta brothers participated in the Susan G. Komen Race for the Cure held at Bayfront Park in downtown Miami. Together, with the Bahamian Students Association in the 5k walk, the

two organizations raised \$300 in the fight against cancer. ★

### RE-ENVISIONING PHILANTHROPIC FUNDRAISING

SOUTH FLORIDA ALPHA PHI ALPHA CHAPTERS, HURRICANE GRILL & WINGS PARTNER TO RAISE MONEY FOR PREMATURE BABIES

The Iota Pi Lambda (IPL, South Miami), Eta Delta (HD, University of Miami), and Zeta Alpha Lambda (ZAL, Ft. Lauderdale) Chapters of Alpha Phi Alpha, Fraternity, Inc. in conjunction with Hurricane Grill and Wings recently raised more than \$4,600 in support of the 2019 March for Babies South Florida Fundraising Campaign.

That campaign, which was Phase II of a four-year-partnership first initiated in 2016 by ZAL chapter with Hurricane Grill and Wings, whose corporate office is located in Coral Springs, FL - one of the municipalities of Broward County, was to extend the philanthropic partnership opportunity to additional chapters in South Florida.

The collaboration involved Alpha Phi Alpha hosting a series of team hot wing eating contests called "Wings for Babies" as well as the restaurants food servers soliciting donations, resulting in the doubling of total March of Dimes donations from years past.

The competition was aired via live stream on several social media platforms, which allowed viewers to pledge their support for March of Dimes and their favorite team. The winning teams received gift cards from either Hurricane Grill and Wings or Target, while individuals with the fastest times (speed champions) received prizes supplied by local partners of the March of Dimes.

IPL's March of Dimes Team Co-Captain, Bro. Chris Stevenson, notes that "the support of our College Brothers was vital...Eta Delta was instrumental to the success of the wing eating contest."

Collectively, Alpha Phi Alpha Chapters within the two counties have raised nearly \$7,000 in support of March of Dimes.

Fouad Hatem, restaurant manager and franchise co-owner of Hurricane Grill and Wings-Kendall says that he is "committed to our cause...and the [brand] will do everything in its power to foster this relationship."

The pact hopes to expand its local partnership agreement to the fraternity's over 700 chapters located throughout the country, operating within the markets of FAT Brands, Inc. family of restaurants. FAT Brands is a leading global franchising company that strategically acquires, markets, and develops fast casual and casual dining restaurant concepts around the world. The

company currently owns seven restaurant brands - Fatburger, Buffalo's Cafe, Buffalo's Express, Hurricane Grill & Wings, Yalla Mediterranean and Ponderosa and Bonanza Steakhouses - with over 300 locations open and more than 300 under development in 32 countries.

The March of Dimes and Alpha Phi Alpha Fraternity, Inc. began collaborating on the fraternity's Project Alpha national program in 1980. Designed to provide young men with the most current information on teen pregnancy prevention and reproductive health, Project Alpha consists of a series of workshops and informational sessions facilitated by Alpha Phi Alpha Fraternity brothers.

The Center for Disease Control (CDC) reports that preterm birth among African American women is about 50 percent higher than the rate of preterm birth among white women. Similarly, black women are 3-4 times as likely to experience birth complications as their peers.

Further analysis suggests that the lack of adequate reproductive health education, primary care resources, and healthcare provider biases remain primary factors to women of color having elevated risk for birthing complications.

This reality hits home, personally, for several brothers in the South Florida area who have had to face the challenges of preterm birth which resulted in terminal outcomes. For these reasons, Brothers have been working diligently to both educate the community and raise funds for this noteworthy cause. **S**



**IPL HOSTS RELAY FOR LIFE IN RICHMOND HEIGHTS, FLA.**

In May, fifteen teams gathered at Sweet Home Baptist Church for the site's first Relay for Life event. The event, organized by Iota Pi Lambda Chapter, hosted more than 100 participants that took part in the 18-hour walk-a-thon, to raise awareness and generate funds for cancer research. Each team tent posted signage information on a different form of cancer. IPL brothers raised nearly \$800. Collectively, participants raised more than \$7,000 for the American Cancer Society.

**ETA SIGMA LAMBDA BROTHERS DEVELOP YOUNG LEADERS IN SILICON VALLEY**

Brothers in the northern California recently conducted their annual Rites of Passage program for teenage boys. Each fall and winter, for 16 weeks, the brothers of Eta Sigma Lambda Chapter in San Jose, Calif., conduct the long-running mentoring and self-maturation program for teenage African-American boys living in Silicon Valley.

The program, operated in partnership with the Oriki Theater of Mountain View, takes the boys through a comprehensive and intensive journey from "boys to men." Each session ends with an authentic African-inspired passage ceremony during which the boys are "returned to the village" (i.e., their families and loved ones) ready to begin to assume the responsibilities of manhood.

Chapter brothers serve as directors on the program's board and as mentoring staff and session facilitators. Adding to the program's success is Eta Sigma Lambda's collaboration with college brothers from Epsilon Mu Chapter at San Jose State University and Nu Sigma Chapter at Stanford University. Together, they have executed the Project Alpha and Go-to-High-School, Go-to-College national programs during the sessions. Four boys completed the program this year, and over the 10-year history of the program, the chapter has facilitated the rites of passage of more than 90 boys.

## South Dade Alphas, AKAs Bring HBCU Opportunities to Homestead High

The Iota Pi Lambda Chapter of Alpha Phi Alpha Fraternity, Inc. (IPL) and Pi Delta Omega Chapter of Alpha Kappa Alpha Sorority, Inc. (PDO) partnered with Homestead Senior High School to host the school's first "Historically Black College and University (HBCU) Fair." The event's objective was to expose Homestead students to unique academic and athletic opportunities offered by institutions that were created to meet increasing education demands of African Americans.

Prior to the Civil Rights Act, African Americans faced many unprecedented challenges to gain access to education and social services during the Reconstruction Era. For a century following the abolishment of slavery in United States (in 1865), African Americans in the southern states were denied admission to post-secondary institutions to pursue higher education. Similarly, several universities across the country adopted quota policies which restricted Black American enrollment numbers to their institutions. As a result, colleges and universities were established for students of African descent to educate subsequent generations of black intellectuals and professionals of color. Currently, there are over 100 HBCUs across the continental U.S. and Caribbean islands between the private and public sectors of education. Having events like the HBCU Fair provides students with a glimpse of the rich collegiate foundation created for African Americans, recited Soror Karla Revere (WVSU Alumna and PDO HBCU for Life Chair).

The college fair featured on-site admission and scholarship opportunities for qualified students to attend some of our nation's top HBCUs. Attendees received a *Passport for Success* which contained suggested questions for college admission officers, answered general questions on securing financial aid, and provided a comprehensive list of participating schools. Soror Bonita Cooper, President of PDO, shared with attendees that "sometimes HBCUs are overlooked and overshadowed by larger colleges and universities. This fair helps to equalize the playing field - exposure is key!" Students who visited all the suggested stops to college admission were eligible to participate in raffles for cash prizes, gift cards to local attractions, or print copies of *iHover: A Parent Guide to Student Success Strategies* written by Soror Tara Turner (PDO).

Devon Grussmark, school-site College Advisor Program Counselor, shared that *the HBCU Fair at Homestead Senior High School was a truly impactful experience for the Bronco community. Thanks to our partnership with the Iota Pi Lambda Chapter of Alpha Phi Alpha Fraternity, Inc. and Alpha Kappa Alpha Sorority, Inc. Pi Delta Omega*

*Chapter, our students had the invaluable opportunity to be recognized for their academic excellence and gain acceptance to some of the country's top schools. They were also able to access the scholarships and grants that all students need to be successful. Additionally, our younger student body had the chance to learn about the unique experiences that these competitive HBCUs have to offer and learn how these institutions would support them in preparing for and earning a meaningful and prosperous career. It was remarkable to watch our Broncos maneuver the fair with excitement and engage with recruiters to build meaningful connections that will continue to support them through their college application process. The event; planned, organized, and facilitated by our incredibly valuable fraternity and sorority partners; is one that created new pathways that our Broncos are excited to explore! In fact, the students are excited about "what's next" and we're excited to see how this partnership grows!*

Following the HBCU Fair, we hosted an HBCU Admissions Boot Camp to help graduating seniors submit their last round of applications to our partner schools and scholarships. Brother Gilbert Estime, who attended both events, expressed that it was a "pleasure to be a part" of this hands-on opportunity to make a difference in the lives of our youth. From these combined activities, we were able to serve 1,000 students, over 110 college acceptance letters were awarded, and amass over a \$1,000,000 in renewable scholarships offers for program participants. Brother Takevess Hatcher (Homestead High Alumnus and Fall 2018 initiate of the IPL) remarked that "these events were a great way to pay forward the opportunities of exposure to college someone afforded me when I was a high schooler." The 2020 class of Broncos is composed of 350 graduating seniors.

Thank you to our HBCU partners in attendance for helping ensure the college fair's success: Howard University, Philander Smith College, Florida Agricultural and Mechanical University, Shaw University, North Carolina Central University, Florida Memorial University, Morehouse College, Grambling State University, and Tennessee State University. Tougaloo College, Fort Valley State University, Albany State University, Savannah State University, Hampton University, University of Maryland-Eastern Shore, Benedict College, Fayetteville State University, North Carolina A&T University, Alabama State University, Talladega College, and Southern University also provided collateral materials to support the activity. The program helped initiate a newly forged agreement between Homestead High School and its 30 HBCU Partners to recruit students from the area and offer them sufficient support and financial resources to attend their respective universities. **S**
